Course description (Syllabus): This module is focused on suffering in the case of complex patients who have symptoms alongside non-physical suffering. Other symptoms than pain will be learned during the module Refractory symptoms will be discussed and palliative care sedation will be presented as an option for refractory symptoms in the last days of life. Symptoms as dyspnea, neurological symptom digestive symptoms, fatigue, psychiatric symptoms are presented. Management of terminal patients and their families in different settings is also part of the module.

Course description (Syllabus): Alleviation of suffering and increased quality of life for patients and the family is the declared aim of the WHO definition of palliative care. The module will bring to students' attentions 2 frameworks for definition of suffering, will explore suffering in different historical and cultural contexts, suffering expressed in art produced by patients and in the different domains of total pain (physical, psychological, social, and spiritual). During the module we will clarify the concept of quality of life and the various tools available to asses quality of life, will discuss narrative assessment in contrast with biomedical assessment in PC, and focus on therapeutically encounter between patients families and care team.
